Dry cleaning establishments must file this renewal application by October 1. Failure to do so will result in a \$200 penalty.

All dry cleaning establishment locations must register with the Department of Revenue Services (DRS) and display a Dry Cleaning Establishment Surcharge Certificate in order to legally conduct business in Connecticut.

Locations not registered with DRS must submit a **Form REG 1, Business Taxes Registration Application** to receive a *Dry Cleaning Establishment Surcharge Certificate*. Register your business online using myconneCT from the DRS website at portal.ct.gov/DRS. The *Dry Cleaning Establishment Surcharge Certificate* must be renewed each year.

Dry cleaning establishments that operate more than one location, including dry cleaning establishment-owned drop stores, must register each location and display a valid *Dry Cleaning Establishment Surcharge Certificate* at each location. If the business has not received a **Form REG 30** for each location it operates, you must submit a **Form REG 1, Business Taxes Registration Application** for each location.

Independent drop stores are not required to be registered for the dry cleaning establishment surcharge. If this entity is an independent drop store that only accepts clothing or other fabrics to be cleaned by a dry cleaning establishment, you can close this location by returning to the **Summary** page, select **More...** and in the **Taxpayer Updates** panel, select the **Close Accounts** hyperlink and close the applicable location.

If the above entity is permanently out of business, you can close this location by returning to the **Summary** page, select **More...** and in the **Taxpayer Updates** panel, select the **Close Accounts** hyperlink and close the applicable location.

If the above entity's information is incorrect or incomplete, you can update the name and address of this location by returning to the **Summary** page, select **More...** and in the **Taxpayer Updates** panel, select the **Manage Names & Addresses** hyperlink and update your records.

There is no fee for a *Dry Cleaning Establishment Surcharge Certificate*. However, unregistered locations conducting business are subject to a mandatory fine of \$1,000.

****DO NOT MAIL REG-30** Once the REG-30 has been successfully submitted, the renewal process is complete.

Declaration

I declare under penalty of law that I have examined this application and, to the best of my knowledge and belief, it is true, complete, and correct. I understand the penalty for willfully delivering a false application to DRS is a fine of not more than \$5,000, or imprisonment for not more than five years, or both.
